During the pre-sale: 1 ETH = 3000 3xD
Early stage ICO: 1 ETH = 2500 3xD
ICO: 1 ETH = 2000 3xD
- This Airdrop and Bounty Campaign will run until one week after the end of the ICO Token Sale. The Airdrop and Bounty Campaign will be paid within 30 days after the end of the Token Sale.
- Every bounty week will be closed on every Sunday at 23:59 UTC.
- All Airdrop and Bounty Campaign participants must register for the campaign, join 3D-Chain's Telegram Channel and Telegram Group, and follow us on Twitter for the duration of the entire campaign.
- 3D-Chain reserves the right to adjust the reward amount, depending on number of applicants in each of the bounty campaigns.
- Stakes depend on your rank at the end of campaign.
- Stakes are calculated internally but will be disclosed at the end.

4.2 Terms of Service

The [3D-Chain](#) Bounty Campaign Terms of Service (hereinafter referred to as the “Agreement”) apply to the “[3D-Chain](#) Bounty Campaign,” which is a referral & participation bounty (Bounty) service provided by 3D-Chain Limited. (hereinafter referred to as the “Company” or [3D-Chain](#)). This Agreement establishes the relationship of rights and obligations between the Company and the [3D-Chain](#) Bounty Campaign Contributors defined in Article 2, Section 2, as well as any former [3D-Chain](#) Bounty Campaign Contributors. For matters not stipulated in this Agreement, the [3D-Chain](#) Terms and Conditions apply.

4.2.1 Article 1 - Overview

The [3D-Chain](#) Bounty Campaign is a Campaign under which the Company pays compensation to any Contributor of the [3D-Chain](#) Bounty Campaign (defined in Article 2) in the case that a Contributor of the [3D-Chain](#) Bounty Campaign uses media to introduce [3D-Chain](#) to a Contributor who is not registered to [3D-Chain](#) (hereinafter referred to as an “Unregistered [3D-Chain](#) Contributor”), and that aforementioned Unregistered [3D-Chain](#) Contributor subsequently uses the bounty link provided by the aforementioned Contributor of the [3D-Chain](#) Bounty Campaign to register as a [3D-Chain](#) Contributor, and moreover uses a service to which compensation applies (to be determined separately), or in the case that the set goal for compensation is met in the Bounty Campaign.

A [3D-Chain](#) Bounty Campaign Contributor is a person who is a [3D-Chain](#) Contributor who has completed the Contributorship registration procedure at [3D-Chain](#), and who has agreed to this Agreement and registered for the [3D-Chain](#) Bounty Campaign in accordance with the method prescribed by the Company.

The [3D-Chain](#) Bounty Campaign Contributor can use a unique link issued via the [3D-Chain](#) Bounty Campaign [Registration](#) page of their account, other [3D-Chain](#) supplied marketing material or other created material for the campaign. Bounty Campaign contributors can find stake information in the supplied completion list.

If a [3D-Chain](#) Bounty Campaign Contributor wishes to cancel their registration as a Contributor of the [3D-Chain](#) Bounty Campaign, they can cancel their registration as a [3D-Chain](#) Bounty Campaign Contributor by withdrawing from the Campaign in accordance with the withdrawal procedure prescribed by the Company.

Contributors of the [3D-Chain](#) Bounty Campaign shall faithfully comply with this Agreement and the terms, rules, guidelines, and similar that accompany this Agreement.

4.2.2 Article 2 - Applicability of this Agreement

A [3D-Chain](#) Bounty Campaign Contributor is a person who has registered as a [3D-Chain](#) Bounty Campaign Contributor for the purpose of using the [3D-Chain](#) Bounty Campaign, and who entered into a relationship of rights and obligations between the Company and the [3D-Chain](#) Contributor concerned upon agreeing to this Agreement in addition to the [3D-Chain](#) [Token Sale Policy](#).

This agreement shall apply to Contributors of the [3D-Chain](#) Bounty Campaign from the moment they register as a [3D-Chain](#) Bounty Campaign Contributor by joining the [Registration](#) for the Bounty Campaigns until the moment their [3D-Chain](#) Bounty Campaign Contributorship is



canceled. However, Articles 8 through 9 shall apply to [3D-Chain](#) Bounty Campaign Contributors even after their [3D-Chain](#) Bounty Campaign Contributorship is canceled.

4.2.3 Article 3 - Compensation

The compensation targets of the [3D-Chain](#) Bounty Campaign, as well as compensation conditions, payment receipt dates, and so on are described separately on the [3D-Chain](#) Bounty Campaign.

However, if the [3D-Chain](#) Bounty Campaign Contributor violates this Agreement or is no longer a [3D-Chain](#) Bounty Campaign Contributor, the aforementioned Contributor of the [3D-Chain](#) Bounty Campaign shall no longer be entitled to compensation (including compensation generated before the aforementioned Contributor of the [3D-Chain](#) Bounty Campaign engaged in the behavior that violated this Agreement, or compensation generated before the aforementioned Contributor of the [3D-Chain](#) Bounty Campaign left the Campaign).

To meet growing worldwide requirements all [3D-Chain](#) Bounty Campaign Contributors will be required supply government issued identification and other supporting Documents to prove who they are. Before Tokens are issued as compensation [3D-Chain](#) Bounty Campaign will conduct and Know Your Customer (KYC) check. All documents are to be uploaded to the [3D-Chain Registration](#) before tokens will be issued.

A [3D-Chain](#) Bounty Campaign Contributor has 3 months to remove their earned stakes from the [Registration](#) or their stakes in [3D-Chain](#) Bounty Campaign will become Null and Void and all tokens will be reallocated to the Pool of [3D-Chain](#).

4.2.4 Article 4 - Changes to this Agreement

The Company may change this Agreement from time to time, and when changes to this Agreement set forth in Section 2 take effect, [3D-Chain](#) Bounty Campaign Contributors shall be deemed to have accepted those changes.

Unless otherwise specified by the Company, changes made to this Agreement shall take effect when the details of the changes are displayed on our website or when the details of the changes are sent to each [3D-Chain](#) Bounty Campaign Contributor by email, whichever comes first.

4.2.5 Article 5 - Representations and Warranties

Upon applying for registration on to the [3D-Chain Registration](#) or applying to one or more of the Bounty Campaigns, a person is registered as a [3D-Chain](#) Bounty Campaign Contributor (hereinafter referred to as the “Applicant”) declares that they meet all the conditions listed below, and guarantees that this situation will continue during the period in which the Agreement is in effect. The Company shall have the right to reject an application for registration if the Applicant is found to be in violation of the guarantees set out in this section, or if the Applicant is judged to be unsuitable for registration for or use of the service.

(1) The Applicant understands and is able to read and write in English.

(2) The Applicant does not operate any websites that endorse violence or abuse, websites that endorse racism, websites that violate laws, or websites that are contrary to public order and morality.

(3) The Applicant is not an organized crime group, a Contributor of an organized crime group, an associate Contributor of an organized crime group, a person connected to an organized crime group, a corporate blackmailer, or similar (hereinafter collectively referred to as “Antisocial



Forces”). The Applicant does not directly or indirectly interact with Antisocial Forces, provide funds or accommodations to Antisocial Forces, do business with Antisocial Forces, or maintain any other type of relationship with Antisocial Forces, and has no capital ties to Antisocial Forces.

(4) The Applicant has not appointed Antisocial Forces as staff or hired them as employees.

(5) The Applicant has not provided false information while registering for **3D-Chain**, or provided false information while using the **3D-Chain** Bounty Campaign.

(6) The Applicant does not aim to obtain compensation from the Company through the **3D-Chain** Bounty Campaign in an unauthorized fashion.

(7) The Applicant has not canceled a registration for the **3D-Chain** Bounty Campaign in the past.

(8) The Applicant possesses the capacity to discern right and wrong and understands the details of this Agreement and the **3D-Chain** Bounty Campaign.

(9) The Applicant does not qualify as someone who is otherwise deemed unsuitable for registration by the Company.

If after registration as a **3D-Chain** Bounty Campaign Contributor, a **3D-Chain** Bounty Campaign Contributor is found not to meet any of the aforementioned conditions, the Company shall have the right to cancel the registration for the **3D-Chain** Bounty Campaign of the aforementioned **3D-Chain** Bounty Campaign Contributor without prior notification.

4.2.6 Article 6 - Prohibited Conduct

Contributors of the **3D-Chain** Bounty Campaign shall not engage in any of the conduct established below (hereafter referred to as “prohibited conduct”).

(1) Possession of two or more accounts per single registration category by the same individual or corporation.

(2) Interfering with the operations of the company, regardless of whether it is intentional or accidental.

(3) Infringing on the copyrights of the company and its other rights.

(4) Defaming the company, or a third party, which harms reputations and inflicts losses.

(5) Infringing on intellectual property rights and other copyrights, personality rights, likeness usage rights and other legal rights, as well as rights worthy of protection, or conduct that violates related laws and regulations.

(6) Violating the privacy of third parties.

(7) Performing activities that are illegal or suspected to be illegal, as well as actions which instigate these activities.

(8) Qualifying as any sort of antisocial force, or interacting—whether directly or indirectly—with any parties which qualify as antisocial forces, offering them funding or facilities, conducting business with them or possessing other relationships with said forces, as well as taking actions that result in possession of capital ties with antisocial forces.

(9) Appointing antisocial forces to staff positions, or employing them as workers.

(10) Making **3D-Chain** referrals by means of conduct that qualifies as religious activity or political solicitation.



(11) Engaging in conduct that misleads regular Contributors into making judgment errors, as well as conduct that this company deems to have a negative influence on the judgment of regular Contributors.

(12) Displaying false information relating to the **3D-Chain** Bounty Campaign or companies offerings.

(13) With regard to this company's services and the like, presenting something not grounded in objective fact so that it will be mistaken as being objective.

(14) With regard to the company's services and the like, making displays that are arbitrary or excessively subjective.

(15) Making inappropriate displays which are neither impartial nor based on objective grounds.

(16) Making displays that excessively solicit dealings with the company.

(17) Engaging in conduct that is illegal or forbidden by this company.

(18) Altering advertising materials or referral codes, or using them for other purposes. Altering the referral links provided by this company (advertising materials as well as those link codes) without permission, using them for purposes other than the **3D-Chain** Bounty Campaign, or using them for improper purposes.

(19) Extortion to Receive Success Rewards Unrelated to this company's services or this website's referrals and advertising, forcibly demanding clicks, registrations, payments, transactions or subscriptions from regular Contributors with the primary aim of collecting fees.

This company shall make a judgment as to whether or not an activity falls under prohibited conduct, and this company assumes no obligation to elaborate on details or its reasoning to **3D-Chain** Bounty Campaign Contributors.

If this company suspects that a **3D-Chain** Bounty Campaign Contributor is engaged in conduct that comes under any item in paragraph 1 of this article, the company can demand that the aforementioned **3D-Chain** Bounty Campaign Contributor submit documents related to the presence or absence of prohibited conduct.
